The scholarship recipient will be **awarded after the completion of their 2024 fall semester**, in which the **student must maintain a 2.0 GPA (grade point average) or higher to be eligible and enrolled in spring 2025 classes**. The student awarded a scholarship will be responsible for providing Atlantic Federal Credit Union with all the documentation required after their fall semester is completed. A request for payment must be provided no later than January 12, 2025. If documentation is not received by January 12, 2025, then the scholarship award will be forfeited. **Once reviewed and approved, the scholarship payment will be mailed to the school's billing address, and the check will be assigned to the school and student.**

## 2024 Amable A. Caron & Vivian Caron College Scholarship Rules

The 2024 Amable A. and Vivian Caron Scholarship program is from October 1, 2024, to November 18, 2024. Members may download the application online at [www.atlanticfcu.com/about/scholarships.html](http://www.atlanticfcu.com/about/scholarships.html).

All applicants must meet the following qualifications to be considered for the \$2,500 scholarship:

1. The college student applying for the scholarship **MUST HAVE** an open account with Atlantic, of **which they are the primary account holder\***.
2. The student must be enrolled for a fall 2024 accredited undergraduate or graduate program at a chosen college/vocational school, with a minimum of 6 credit hours per semester, and maintain a 2.0 GPA.
3. The student must complete the scholarship application.
4. The student must complete an essay on this topic: **Who is your favorite mentor, and how have they impacted your life?** (250 words minimum - 350 words maximum).

The Scholarship winner is responsible for submitting a request for payment to [scholarships@atlanticfcu.com](mailto:scholarships@atlanticfcu.com) with the required documents (**fall 2024 grades, spring 2025 schedule, school billing address, and student ID number**) prior to award payment. A request for payment must be provided no later than January 12, 2025. If documentation is not received by January 12, 2025, then the scholarship award will be forfeited. Once reviewed and approved, the scholarship payment will be mailed to the school's billing address, and the check will be assigned to the school and student.

All applications must be received or postmarked by November 18, 2024. Applications received after this date will be ineligible.
